



This document provides detailed information on our 3 Angels Message Discipleship Program for Prison Ministry. Please read over this documentation in full and complete any sections labeled to be filled out. Once this is done, we can get started with the process on our end.

Many people, even in our great nation are misguided, mistreated, hungry, cold, and alone. This particular ministry has a heart for those who have, like all of us, made terrible choices and mistakes in their lives. Many of us simply have not been caught, or we have paid consequences in some other way, but there are those of us who have traded their individual rights and many freedoms in exchange for their deeds. Until our last breath we have an opportunity to repent and to witness to others, in fact that is the true reason some of us are caught and put in prison to begin with. This ministry allows those of us who feel a call to put into practice the concepts Yeshua (Jesus) gave us when He made the following statements:

- Matthew 25:34-36, 40: "...Come, you whom my Father has blessed, take your inheritance, the Kingdom prepared for you from the founding of the world. ³⁵ For I was hungry and you gave me food, I was thirsty and you gave me something to drink, I was a stranger and you made me your guest, ³⁶ I needed clothes and you provided them, I was sick and you took care of me, I was in prison and you visited me.' ⁴⁰ The King will say to them, 'Yes! I tell you that whenever you did these things for one of the least important of these brothers of mine, you did them for me!'"
- Luke 21:12-13: "But before all this, they will arrest you and persecute you, handing you over to the synagogues and prisons; and you will be brought before kings and governors. This will all be on account of me, but it will prove an opportunity for you to bear witness."
- Acts 5:19-20: "But during the night, an angel of ADONAI opened the doors of the prison, led them out and said, "Go, stand in the Temple court and keep telling the people all about this new life!"

This is why we feel this is an important program to provide to our fellow disciples as they herald the coming of the Kingdom of God.

3 Angels Message Ministry will research and provide the application for you to proceed with a prison ministry in your local prison system so that you can provide the time, support, council, literature or other things your divine contacts may need for nourishment, encouragement, and support in any area, emotionally, spiritually, and psychologically. This is done in a way that is safe for the participants and inmates involved in the program. You may not have direct contact with many of the inmates you hope to sponsor but will be able to leave packages and envelopes at the prison or sheriff's station for them to be delivered. Often you will be permitted entry and visitation during visitation times and dates.

If you have any questions or concerns while filling out the information or once you are actively participating in the program, we are generally available Monday through Thursday, 9 am to 5 pm MST. We are available by phone, email, and fax. Because our in-house staff is still small, and we often are unable to answer calls as they come in. However, we hope you can leave a message including the best number to reach you at and a time that we can call and discuss our services, ministry opportunities, and programs.

This is a voluntary discipleship program that provides for the needs of convicted criminals or those awaiting trial in your local prison system under guidelines negotiated with and dictated by the prison system, individual state, county, city, or institutional laws, policies, and regulations involved. Under these guidelines, it is possible you may be able to receive letters or other items from those you correspond with in appreciation for, or in response to, your time, efforts, or donations.

Any products you purchase and provide as donations in this ministry can be considered a tax-deductible donation through our ministry. Another option is that the institution, if a not-for-profit institution, may offer their own programs.

That is why we will provide more information on how to claim deductions for your donations once negotiations are complete and prior to executing your local ministry.

You will need a notary public to notarize this document. Your signature must be placed in this document in the notary's presence. You cannot sign the document ahead of time and then bring it to the notary.

I, _____, being of sound mind and over the age of 18 years old, hereby agree to abide by the terms and conditions negotiated by 3 Angels Message Ministry with my local juvenile detention center, jail, prison or prison system to participate in any existing Prison Ministry Program they may offer. I understand I am not operating as a representative of 3 Angels Message Ministry, but under my own conviction, power, and authority. I have taken it upon myself to sponsor local prisoners in need by providing charitable donations as good-will offerings, free of charge, no strings attached, and with lawful intent, as requested or directed by those with authority, and greatest responsibility for the inmate(s) I will be visiting and/or sponsoring.

I understand I am responsible to abide by the terms negotiated by the above-mentioned parties. I further understand that if I deviate from those terms and conditions, I will be held accountable by no longer receiving support to continue my sponsorship by either organization or institution.

Finally, if any malicious or criminal intent or act is suspected or committed by any parties involved, or by an outside individual or party, against the inmate and/or their sentence registered with this program, such suspicion and or evidence will be reported to the proper authorities immediately. This information will also be provided prior to the execution of my personal ministry so that I can provide additional service to the participants for the well-being of everyone involved.

Often, there is a fee to have a document notarized. The maximum amount a notary public may charge for services is regulated by state law. However, if you do business with or have open accounts with a local bank or other financial institution, sometimes they provide notary services free of charge.



Items you will need to bring: The completed document you wish to notarize; Valid photo ID that meets state requirements (generally a state issued driver’s license or passport); Payment for notarial service.
